(1) Chairman's welcome and introduction

Cllr Mclean welcome everyone to the meeting. He announced that he was standing down from the Parish Council, so this would be his last meeting.

- (8) **Defibrillator location –** There was a discussion about possible locations, as a number of residents & businesses are reluctant to host because of the fitting & ongoing costs. It was agreed to meet with the Duchy to discuss a location.

 - **a.** Village Fountain The Duchy are putting in an application to BaNES planning, as this is a listed item & a more complicated restoration than first anticipated.

Cllr Singleton reported on the potential new recycling centre in Keynsham, a new pothole repair system that is carbon neutral & the new voter ID regulations, that will be introduced for the May 2023 local elections. As he will be standing down in May, he was thanked for his work over the last 4 years.

(11) Playground -

The temporary repair to the monkey rings has meant that the playground has now reopened. However the long term future is not clear, as the cost of replacement is outside the financial scope of the Parish Council. As the land is owned by the Duchy it was agreed to discuss this with them. It is possible that the play equipment may have to be removed & not replaced as it comes to the end of its useful & safe life.
